A. PRODUCT DESCRIPTION

Crushed pineapple is prepared from finely cut (fine crushed) or coarsly cut (coarse crushed) pineapple in its own juice or in syrup made from clarified juice and sugar, packed in cans and hermetically sealed and heat treated for preservation.

Product code: FIM for fine crushed, BIM for coarse crushed in juice, 1M for coarse crushed in syrup.

The I is replaced with an H for the A10 heavy drained weight product.

B. CONTAINER DESCRIPTION

Three piece welded can with plain body and lacquered ends. One end may be easy open.

N1F (307 x 201¼) SA2 (307x309) 2T (307x409) A10 (603x700)

C. ORGANOLEPTIC REQUIREMENTS

Colour

Fairly uniform colour, light yellow to bright golden yellow

Flavour

Must be normal and free from any objectionable flavour or odour.

Style

Coarse Crushed;

The majority of fruit particles are between 6mm and 13mm with maximum 5% above 13mm.

Fine Crushed;

Practically all fruit particles are less than 6mm

Blemishes

May contain not more than 0.03 % blemished units or extraneous vegetable matter such as

leaf, eyes, skin, seeds by drained weight.

Less than 3mm blemishes or extraneous vegetable matter - Maximum 25 pcs in A10, 7 pcs in 2T,

5 pcs in SA2, and 3 pcs in NIF.

Less than 10mm blemishes or extraneous vegetable matter - Maximum 10 pcs in A10, 2 pcs in 2T,

and SA2, and 1 pcs in NIF.

Total blemishes

Maximum 35 pcs in A10, 9 pcs in 2T, 7 pcs in SA2, and 4 pcs in NIF.

Core

Not more than 1.0% core material by weight may be present.
